A LAW to make provision for a standard scale of fines for offences against enactments

Commencement [[see endnotes](#)]

1 Standard scale of fines

- (1) There shall be a standard scale of fines for offences which shall be known as the “standard scale”.
- (2) The standard scale shall be as set out in the Schedule.
- (3) The States may from time to time by Regulations vary any of the amounts specified in the second column of the standard scale.

2 Construction of enactments

Where an enactment provides or confers a power to provide that a person convicted of an offence shall be liable on conviction to a fine by reference to a specified level on the standard scale or, in the case of an enactment in the French language, by reference to a specified *niveau du tarif uniforme*, that reference shall be construed as a reference to the standard scale for the time being.¹

This Law may be cited as the Criminal Justice (Standard Scale of Fines) (Jersey) Law 1993.
