ROAD TRAFFIC (ST. OUEN) (JERSEY) ORDER 19791

THE ENVIRONMENT AND PUBLIC SERVICES COMMITTEE, in pursuance of Articles 62 and 84 of the <u>Road Traffic (Jersey) Law 1956</u> and after consultation with the Connétable of St. Ouen, orders as follows –

PART 1

INTRODUCTORY

1 Application

This Order applies to the roads in the parish of St. Ouen.

2 Interpretation

In this Order, unless the context otherwise requires -

"Connétable" means the Connétable of St. Ouen;

"Motor Traffic Law" means the Motor Traffic (Jersey) Law 1935;

"road" includes part of a road.

PART 2

TRAFFIC CIRCULATION

3 One-way traffic

A vehicle being driven on a road specified in the first column of Schedule 1 shall, between the point of its entry therein and its departure therefrom, follow the direction prescribed in relation to that road in the second column of that Schedule.

4 Prohibition of waiting and stopping

- (1) A vehicle shall not wait on any road specified in the first and second columns of Schedule 2.
- (2) A vehicle shall not wait on a road within 10 yards of its junction with another road.
- (3) A vehicle, other than a public service vehicle of the appropriate class, shall not stop on any part of a road which is authorized under Article 37 of the Motor Traffic Law as a stand for public service vehicles.
- (4) A vehicle shall not wait on any part of a road which has been designated as a no waiting area for the purpose of allowing access to any premises from that part of that road.
- (5) The expression "waiting" in this Article does not include the stopping of a vehicle to set down or pick up passengers.

5 Driving and stationing of certain vehicles²

- (1) Except with the permission in writing of the Connétable or on the express direction of a police officer, no char-à-banc shall be driven on any road specified in the first and second columns of Part 1 of Schedule 3.³
- (2) Except with the permission in writing of the Connétable, no char-à-banc shall be stationed on any road.
- (3) Except on the express direction of a police officer, no cab shall be stationed on any road:

Provided that this paragraph shall not apply to the stationing of a controlled taxi-cab on a taxi rank as defined in the Motor Traffic (Taxi-Cabs - General) (Jersey) Order 2002.⁴

- (4) In paragraphs (1) to (3), "cab" and "char-à-banc" have the same respective meanings as under the Motor Traffic Law.⁵
- (5) Except with the permission in writing of the Connétable, no vehicle, the overall width of which exceeds 6 feet 6 inches, shall be driven on any road specified in the first and second columns of Part 2 of Schedule 3 unless it is
 - (a) being driven to or from any premises situated on or adjacent to a road within that area; or
 - (b) a vehicle engaged in mechanical road sweeping or road gully cleaning.⁶

6 **Prohibition or restriction of turns**⁷

A vehicle shall not be driven so as to make a right-hand turn from a road specified in the first column of Schedule 5 into a road specified opposite that road in the second column of Schedule 5.

7 Stopping of vehicles at certain road junctions⁸

(1) Subject to paragraph (2), no vehicle shall enter any area marked for the purposes of this Article on the surface of a road at the junction of any group of roads specified in Schedule 4 if the driver of that vehicle has reasonable cause to believe that, due to

the presence of stationary vehicles, any part of the vehicle will remain stationary within that area.

- (2) A vehicle may remain stationary within any area described in paragraph (1) for so long as it is prevented from completing a right turn by reason of
 - (a) oncoming vehicles; or
 - (b) the presence of other stationary vehicles waiting in or near that area to complete a right turn.

7A Parking of motor cycles and mopeds⁹

A road specified in Schedule 6 is designated as a parking place at which only a motor cycle or moped may park.

PART 3

MISCELLANEOUS

8 Savings

- (1) Article 4 shall not apply to any vehicle while it is being used for fire brigade, ambulance, police or other emergency purposes.
- (2) Article 4 shall not apply
 - (a) so as to prevent a public service vehicle waiting on a part of any road which is authorized in accordance with Article 37 of the Motor Traffic Law, as a stand for public service vehicles;
 - (b) to a vehicle waiting on any road while any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged is being opened or closed, if it is not reasonably practicable for the vehicle to wait otherwise than on that road while such gate or barrier is being opened or closed;
 - (c) to a vehicle waiting on any road on the express direction or with the specific permission of a police officer;
 - (d) to a vehicle stopping on any road owing to the driver being prevented from proceeding by circumstances beyond the driver's control or to a vehicle stopping in order to avoid an accident.¹⁰

This Order may be cited as the Road Traffic (St. Ouen) (Jersey) Order 1979.

La Route de Plémont	Both sides (from its junction with La Rue du Val Bachelier and La Route de Vinchelez for a distance of 152 yards in a northerly direction).
	South side (from its junction with La Rue de Petit Plémont for a distance of 35 yards in a westerly direction).
	East side (from its northern extent for a distance of 220 yards in a southerly direction).
	West side (from a point 25 yards to the south of its northern extent

	for a distance of 4 yards in a southerly direction).
	West side (from a point 50 yards to the south of its northern extent for a distance of 165 yards in a southerly direction).
La Route de Vinchelez	Both sides (from its junction with La Route de Plémont and La Rue de la Porte to its junction with La Rue de la Croute).
La Rue de Petit Plémont	The entire road.
La Rue de la Forge	Both sides (from the junction with La Grande Route de St. Ouen eastwards for a distance of 100 yards).
La Rue de la Fosse	Both sides (from its junction with La Route du Marais for a distance of 23 yards in a northerly direction).

A 10 foot wide lane, measured from the eastern boundary of the car park adjoining Colleen's Cafe, westwards and then northwards to the limit of the land under the administration of the Minister for Infrastructure where it joins that under the administration of the Minister for Sustainable Economic Development at the bunker north of the Café Casino.
