## HEALTH INSURANCE (MEDICAL BENEFIT) (JERSEY) REGULATIONS 2005

THE STATES, in pursuance of Articles 9 and 29 of the [Health Insurance \(Jersey\) Law 1967](#), have made the following Regulations –

### 1 Interpretation<sup>1</sup>

In these Regulations, unless the context otherwise requires –

“Law” means the [Health Insurance \(Jersey\) Law 1967](#).

### 2 Rates of medical benefit<sup>2</sup>

- (1) The general rate of medical benefit for the provision of medical services is £20.28.<sup>3</sup>
- (2) Where, during a consultation, the service of taking one or more blood samples for the purposes of a haematological test in a laboratory is provided, the rate of medical benefit for the provision of the service is £10.35.<sup>4</sup>
- (3) Where, during a consultation, the service of taking one or more blood samples for the purposes of a clinical chemistry test in a laboratory is provided, the rate of medical benefit for the provision of the service is £10.35.<sup>5</sup>

### 4 Date of applicability of rates

The rates of benefit prescribed by these Regulations apply to medical services provided on or after 27th June 2012.<sup>7</sup>

These Regulations may be cited as the Health Insurance (Medical Benefit) (Jersey) Regulations 2005.
