HEALTH INSURANCE (MEDICAL BENEFIT) (JERSEY) REGULATIONS 2005

THE STATES, in pursuance of Articles 9 and 29 of the <u>Health Insurance</u> (<u>Jersey</u>) <u>Law 1967</u>, have made the following Regulations –

Commencement [see endnotes]

1 Interpretation¹

In these Regulations, unless the context otherwise requires –

"Law" means the Health Insurance (Jersey) Law 1967.

2 Rates of medical benefit²

- (1) The general rate of medical benefit for the provision of medical services is £20.28.³
- (2) Where, during a consultation, the service of taking one or more blood samples for the purposes of a haematological test in a laboratory is provided, the rate of medical benefit for the provision of the service is £10.35.4
- (3) Where, during a consultation, the service of taking one or more blood samples for the purposes of a clinical chemistry test in a laboratory is provided, the rate of medical benefit for the provision of the service is £10.35.⁵

4 Date of applicability of rates

The rates of benefit prescribed by these Regulations apply to medical services provided on or after 27th June 2012.⁷

5 Citation

These Regulations may be cited as the Health Insurance (Medical Benefit) (Jersey) Regulations 2005.
