**THE STATES,** subject to the sanction of Her Most Excellent Majesty in Council, have adopted the following Law –

# ARTICLE 1

The Court established by virtue of the "Loi (1853) établissant la Cour pour la répression des moindres délits<sup>1</sup>", as amended, shall henceforth be known as the Magistrate's Court.

## **ARTICLE 2**

The enactments specified in the first column of the Schedule to this Law are amended to the extent and in the manner set out in the second column thereof.

#### ARTICLE 3

In the construction of, and for the purposes of, any enactment, judgment, order, "acte" or other document, a reference to the –

- (a) Police Court; or
- (b) Magistrate's Court,

shall be construed as a reference to the Court established by virtue of the "Loi (1853) établissant la Cour pour la répression des moindres délits", as amended.

## **ARTICLE 4**

This Law may be cited as the Police Court (Change of Name) (Jersey) Law 1996 and shall come into force on such day as the States may by Act appoint.
