ROAD TRAFFIC (ST. HELIER AMENDMENTS) (JERSEY) ORDER 2009

Made
Coming into force

27th February 2009 13th March 2009

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, in pursuance of Articles 62, 63, 64 and 84 of the Road Traffic (Jersey) Law 1956¹, and after consultation with the Connétable of St. Helier, orders as follows –

PART 1

AMENDMENTS TO THE ROAD TRAFFIC (ST. HELIER) (JERSEY)
ORDER 1996

1 Road Traffic (St. Helier) (Jersey) Order 1996 amended

The Road Traffic (St. Helier) (Jersey) Order 1996² is amended as set out in this Part.

2 Article 6 amended

For Article 6(5) there is substituted the following paragraph –

"(5) A vehicle the overall width of which exceeds 6 feet 6 inches shall not wait on any roads listed in Parts 1, 2, 3A, 4 or 6 of Schedule 8.".

3 Article 10 amended

In Article 10(1), in the definition "parking", for sub-paragraph (b), there is substituted the following sub-paragraph –

"(b) between the hours of 8 a.m. and 5.30 p.m. on any day, other than a Sunday, on any road specified in Part 3A, 4, 6, 7 or 8 of Schedule 8;".

4 Article 11 substituted

For Article 11 there is substituted the following Article –

"11 Designation of paying parking places

- (1) The roads specified in Parts 1, 2 and 3 of Schedule 8 are designated as paying parking places.
- (2) Except as provided by paragraph (4) and Article 29, a vehicle that displays a parking card under Article 14 may be parked in a paying parking place for the period of time specified for that Part in paragraph (3).
- (3) Except as provided by Article 2(2)(a) of the Road Traffic (Disabled Persons) (Parking) (Jersey) Order 2002 and Article 29 of this Order, the maximum period for which a vehicle may be parked at a paying parking place specified in Part 1, 2 or 3 of Schedule 8 is
 - (a) in respect of a paying parking place specified in Part 1 20 minutes;
 - (b) in respect of a paying parking place specified in Part 2 1 hour;
 - (c) in respect of a paying parking place specified in Part 3 2 hours.
- (4) A person must not park a vehicle in a paying parking place within 1 hour of the vehicle leaving the parking place after having been parked there.".

5 Article 12 amended

For Article 12(3) there is substituted the following paragraph –

"(3) Except as provided by Article 29 a vehicle shall not be parked at a paying parking place for longer than the maximum period of time specified in Article 11(3).".

6 Article 20 substituted

For Article 20 there is substituted the following Article –

"20 Parking of vehicles displaying parking discs

- (1) Except as provided by paragraph (5) and Article 29, a vehicle that displays a parking disc under this Part may be parked on a road specified in Part 3A, 4, 6 or 7 of Schedule 8 for the period of time specified for that Part in paragraph (2).
- (2) The maximum period for which a vehicle may be parked on a road specified in Part 3A, 4, 6 or 7 of Schedule 8 is
 - (a) in respect of a road specified in Part 3A 10 minutes;
 - (b) in respect of a road specified in Part 4 2 hours;

- (c) in respect of a road specified in Part 6-3 hours;
- (d) in respect of a road specified in Part 7 6 hours.
- (3) Except as provided by paragraph (5), a vehicle that displays a parking disc under this Part may, while it is in use by a person in the course, and for the purposes, of the person's own trade or business, be parked on a road specified in Part 8 of Schedule 8 for a period not exceeding 1 hour.
- (4) Except as provided by Article 29, a vehicle must not be parked on a road specified in Part 3A, 4, 6, 7 or 8 of Schedule 8 for longer than the maximum period of time specified in relation to that Part in paragraph (2) or (3).
- (5) Except for a vehicle that is parked in accordance with Article 29, a vehicle that has been parked in a road specified in Part 3A, 4, 6, 7 or 8 of Schedule 8 shall not return to any part of the same road within one hour of its departure."

7 Article 21 substituted

For Article 20 there is substituted the following Article –

"21 Indication of time on, and display of, parking discs

- (1) Except as provided by Article 29, when a vehicle is parked on a road specified in Part 3A, 4, 6, 7 or 8 of Schedule 8 a parking disc, indicating the time at which the vehicle arrived there must be displayed
 - (a) against the internal face of the windscreen of the vehicle; or
 - (b) if the vehicle has no windscreen, at a convenient place on the left or near side of the vehicle, in such manner that the time of arrival of the vehicle may be distinctly seen by any person outside the vehicle.
- (2) Subject to Article 29, when a vehicle is parked on a road specified in Part 3A, 4, 6, 7 or 8 of Schedule 8 a person must not
 - (a) display more than one parking disc on the vehicle;
 - (b) indicate on the parking disc a time different from that at which the vehicle was parked;
 - (c) alter the time of arrival indicated on the parking disc whilst the vehicle is parked on that road.".

8 Article 28 amended

In Article 28, for the definitions "Cheapside Zone", "Richmond Road Zone" and "St. Mark's Zone" there are substituted, respectively, the following definitions –

"'Cheapside Zone' means the area bounded by the red line in the plan labelled Plan C in Part 1 of Schedule 9;";

- "'Richmond Road Zone' means the area bounded by the red line in the plan labelled Plan B in Part 1 of Schedule 9;";
- "'St. Mark's Zone' means the area bounded by the red line in the plan labelled Plan A in Part 1 of Schedule 9;".

9 Schedule 2 amended

In Schedule 2 -

- (a) in Part 1, the item in respect of Upper Midvale Road is deleted; and
- (b) in Part 3, the item in respect of Midvale Road is deleted.

10 Schedule 3 amended

In Schedule 3, after the group of roads starting with Savile Street, there is inserted the following group of roads –

"Trinity Road

Springfield Road

Parade (eastern arm)

Union Street".

11 Schedule 4 amended

In Schedule 4 –

(a) for the item in respect of Don Street, there is substituted the following item –

"Don Street

East side (between the pedestrian precinct and a point 34 yards north)

East side (between Burrard Street and a point 48 yards north of the pedestrian precinct)

East side (between the northern boundary of the States Public Library and a point 14 yards south)

West side (between the pedestrian precinct and a point 42 yards south of Burrard Street)

West side (between Burrard Street and Craig Street)";

(b) for the item in respect of the Esplanade, there is substituted the following item –

"Esplanade

North side (between Gloucester Street and Victoria Avenue)

North side (between La Route de la Libération and a point 23 yards east of the eastern boundary of Marina Court)

North side (between Payn Street and Castle Street)

North side (between its junction with Castle Street and a point 36 yards east)

North side (between a point 61 yards east of its junction with Castle Street and a point 17 yards further east)

North side (between a point 134 yards east of its junction with Castle Street and a point 54 yards further east)

North side (between a point 19 yards west of Conway Street and Weighbridge Place)

South side";

(c) for the item in respect of Hill Street, there is substituted the following item –

"Hill Street

South side

North side (between its junction with Halkett Place and a point 10 yards east)

North side (between a point 66 yards east of its junction with Halkett Place and its junction with Snow Hill)";

(d) for the item in respect of Library Place, there is substituted the following item –

"Library Place

North side

South side (between Church Street and the eastern boundary of Barclays Bank)";

(e) for the item in respect of Mont Cochon, there is substituted the following item –

"Mont Cochon

East side (between La Route de St. Aubin and Rue de Trachy)

West side (between its junction with La Route de St. Aubin and a point 37 yards north)

West side (between a point 69 yards north of its junction with La Route de St. Aubin and its junction with Rue de Trachy)";

(f) for the item in respect of Seale Street, there is substituted the following item –

"Seale Street

North side (between the western boundary of No. 18 and the western boundary of No. 14)

North side (between a point 38 yards east of the western boundary of No. 14 and York Street)

South side";

(g) for the item in respect of St. John's Road, there is substituted the following item –

"St. John's Road

Both sides";

(h) for the item in respect of Windsor Road, there is substituted the following item –

"Windsor Road

South side (between Great Union Road and a point 4 yards west of the eastern boundary of No. 24)

South side (between its junction with Val Plaisant and a point 15 yards west)

North side (between its junction with Great Union Road and the east side of the entrance to Caesarea Court car park)".

12 Schedule 5 amended

"Hill Street

North side (between a point 21 yards east of its junction with Halkett Place, and a point 45 yards further east)";

(g) for the item in respect of Weighbridge Place, there is substituted the following item –

"Weighbridge Place

North side (between a point 17 yards west of its junction with Wharf Street and a point 15 yards further west)".

South side (between a point opposite the western boundary of Harbour View Apartments and the western side of the northern slipway to the English Harbour)".




PLAN A

ST. MARK'S ZONE




PLAN B
