## 1 Road Traffic (Disabled Persons) (Parking) (Jersey) Order 2002 amended

This Order amends the Road Traffic (Disabled Persons) (Parking) (Jersey) Order 2002.

2 Schedule 1 (parking places for vehicles used by disabled persons) amended
In Schedule 1 before the heading "ST. BRELADE" and "Parking Places - $\mathbf{4}$ hour limit" there is inserted -
"GROUVILLE
Parking places - 2 hour limit
La Rue a Don $\quad \begin{aligned} & \text { North side (between the eastern entrance of } \\ & \text { Grouville Parish Church and a point } 13 \text { yards } \\ & \text { further east) }\end{aligned}$
Parking places - 1 hour limit
La Rue de la Haye du Puits North side (between a point 65 yards west of its junction with Rue de la Croix and a point 13 yards further west)".
