## SOCIAL SECURITY (COLLECTION OF CLASS 1 AND CLASS 2 CONTRIBUTIONS) (AMENDMENT No. 2) (JERSEY) ORDER 2022

**THE MINISTER FOR SOCIAL SECURITY** makes this Order under Articles 11 and 51 of the <u>Social Security (Jersey) Law 1974</u> –

# Social Security (Collection of Class 1 and Class 2 Contributions) (Jersey) Order 2013 amended

- (1) The <u>Social Security (Collection of Class 1 and Class 2 Contributions)</u> (<u>Jersey) Order 2013</u> is amended as follows.
- (2) In Article 1 (interpretation)
  - (a) the definition "contribution quarter" is deleted;
  - (b) after the definition "Law" there is inserted –
  - ""payment due date" in relation to Class 1 and Class 2 contributions means the 15th day of the month following the month in respect of which the contributions are payable."
- (3) In Article 5 (Class 1 contributions), for paragraphs (1) to (4) there is substituted
  - "(1) An employer must, on or before the payment due date, pay to the Comptroller the Class 1 contributions payable in respect of each of the employer's employees.
  - (2) A payment of Class 1 contributions must be accompanied by the information relating to it that the Comptroller requires in a form approved by the Comptroller.".
- (4) For Article 6 there is substituted –

### "6 Class 2 contributions

(1) Except as provided by paragraph (2), an insured person liable to pay a Class 2 contribution in respect of a month must pay to the Comptroller the contribution payable in respect of that month on or before the payment due date.

- (2) The Comptroller may, in any particular case or type of case, extend the payment due date by up to 2 months.
- (3) A payment of Class 2 contributions by a person who is liable to, or who is entitled to, pay Class 2 contributions must be accompanied by the information relating to it that the Comptroller requires in a form approved by the Comptroller.".
- 2 Article 2 (modification of the time limit for payment of Class 1 contributions) of the <u>Social Security (Contributions) (Covid-19) (Jersey)</u>
  Order 2020 amended

In Article 2 of the <u>Social Security (Contributions) (Covid-19) (Jersey)</u> Order 2020 for "Article 5(2)" there is substituted "Article 5(1)".

#### 3 Citation and commencement

This Order may be cited as the Social Security (Collection of Class 1 and Class 2 Contributions) (Amendment No. 2) (Jersey) Order 2022 and comes into force on 1st October 2022.
