## ROAD TRAFFIC (ST. HELIER) (AMENDMENT No. 19) (JERSEY) ORDER 2006

Made16th June 2006Coming into force23rd June 2006

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, in pursuance of Articles 62, 63, 64 and 84 of the Road Traffic (Jersey) Law 1956<sup>1</sup> and, after consultation with the Connètable of St. Helier, orders as follows –

#### 1 Interpretation

In this Order, "principal Order" means the Road Traffic (St. Helier) (Jersey) Order 1996<sup>2</sup>.

#### 2 Schedule 4 amended

In Schedule 4 to the principal Order –

- (a) in column 2, for the first entry opposite the item "Broad Street" in column 1 there shall be substituted the following entry
  - "North side (between the western boundary of No. 36 Broad Street and a point 21 yards east)";
- (b) in column 2, for the second entry opposite the item "Broad Street" in column 1 there shall be substituted the following entry
  - "North side (between a point 82 yards east of the western boundary of No. 36 Broad Street and its junction with Conway Street)";
- (c) in column 2, for the first entry opposite the item "Church Street" there shall be substituted the following entry
  - "East side (between its junction with Hill Street and a point 13 yards north, and between a point 23 yards north of its junction with Hill Street and a point 3 yards north of Royal Court Road)";

Article 3

(d) for the item "Parade, The (western arm)" in column 1 and the entries opposite in column 2, there shall be substituted the following item in column 1 and entries opposite it in column 2 –

"Parade, The (western arm)

East side (between a point 75 yards south of the south side of Gloucester Street and York Street)

East side (between the south side of Gloucester Street and a point 43 yards south)

East side (between the northern side of Gloucester Street and Elizabeth Place)

West side (between Gloucester Street and a point 46 yards south)

West side (between a point 68 yards south of its junction with Gloucester Street and its junction with Union Street)

West side (between the north side of Gloucester Street and a point 30 yards north)

West side (between a point 57 yards north of its junction with Gloucester Street and a point 42 yards further north)

West side (between a point 112 yards north of its junction with Gloucester Street and its junction with Kensington Place)".

#### 3 Schedule 6 amended

In Schedule 6 to the principal Order, for Part 3 there shall be substituted the following Part –

Old Street Pedal cycles

Vine Street Jurats' vehicles (Monday to Friday); vehicles used by disabled persons (Saturdays and Sundays)".

#### 4 Schedule 8 amended

- In Schedule 8 to the principal Order, in Part 1
  - in the item "Broad Street" in column 1 there shall be substituted for the entry opposite in column 2 the following entry –

"North side (between a point 29 yards east of the western boundary of No. 36 Broad Street and a point 21 yards further east)":

- the item "Library Place" in column 1 and the entry in column 2 (b) opposite shall be deleted.
- In Schedule 8 to the principal Order, in Part 2, for the item "Parade, The (2) (western arm)" in column 1 and the entries opposite in column 2 there shall be substituted the following item and entries –

East side (between a point 43 yards south of Gloucester Street and a point 32 yards further south)

> West side (between a point 22 yards north of the northern boundary of the Town Hall and a

point 11 yards further north)

West side (between a point 42 yards north of the northern boundary of the Town Hall and a point 14 yards further north)

West side (between a point 134 yards north of the northern boundary of the Town Hall and a point 11 yards further north)

West side (between a point 30 yards north of Gloucester Street and a point 27 yards further north)".

#### 5 Schedule 10 amended

  - (a) after the item "Beresford Street" in column 1 and the entries opposite in columns 2 to 4 there shall be inserted the following item and entries –

(b) after the item "Charing Cross" in column 1 and the entries opposite in columns 2 to 4 there shall be inserted the following item and entries in those columns –
