SOCIAL SECURITY (GENERAL BENEFIT) (AMENDMENT) (JERSEY) ORDER 2001

THE EMPLOYMENT AND SOCIAL SECURITY COMMITTEE, in pursuance of Articles 13, 14, 29 and 51 of the Social Security (Jersey) Law 1974, 1 as amended, 2 orders as follows -

- 1. In this Order, "principal Order" means the Social Security (General Benefit) Order 1975,³ as amended.⁴
- **2.** For the words "widow's benefit" where they occur in paragraphs (a) and (b) of Article 2 of the principal Order there shall be substituted the words "survivor's benefit".
- **3.** For the words "widow's benefit" in Article 10(3) of the principal Order there shall be substituted the words "survivor's benefit".
- **4.** For the First Schedule to the principal Order there shall be substituted the schedule set out in the Schedule to this Order.
- **5.** This Order may be cited as the Social Security (General Benefit) (Amendment) (Jersey) Order 2001 and shall come into force on the first day of April 2001.

"FIRST SCHEDULE

PROVISIONS FOR THE PURPOSES OF WHICH DISQUALIFICATIONS UNDER THE LAW ARE TO BE DISREGARDED.
