THE MINISTER FOR INFRASTRUCTURE, after consultation with the Connétable of St. Helier, makes this Order under Articles 62, 63, 64 and 84 of the Road Traffic (Jersey) Law 1956¹ –

1 Interpretation

This Order amends the Road Traffic (St. Helier) (Jersey) Order 1996².

2 Article 32 (fees for permit) amended

In Article 32(1) -

- (a) in sub-paragraph (a)(i) for "£293" there is substituted "£326.81";
- (b) in sub-paragraph (a)(ii) for "£146" there is substituted "£162.37";
- (c) in sub-paragraph (b) for "£219" there is substituted "£242.80".

3 Schedule 1 (one-way traffic) amended

In Schedule 1 –

(a) in Part 1, after the item "Great Union Street" and its entry there is inserted –

"Green Street (between a point 80 yards south of its junction with La Route du Fort and a point 70 yards south of La Route du Fort";

- (b) in Part 2, the item "Green Street" and its entry are deleted;
- (c) in Part 3 before the item and entry relating to King Street there is inserted –

"Green Street

Omnibuses, pedal cycles".

4 Schedule 4 (prohibition of waiting) amended

In Schedule 4 -

(a) in the item "Colomberie" after its last entry there is inserted –

"South side (between its junction with St. Clement's Road and a point 38 yards east of its junction with Roseville Street)";

(b) in the item "Commercial Buildings" after its last entry there is inserted –

"East side (from a point 7 yards south of the Tunnel to a point 5.5 yards north then continuing to a point 7 yards west then continuing to a point 17.5 yards south)";

- (c) in the item "Conway Street" after its last entry there is inserted "East side";
- (d) after the item "Dorset Street" and its entries there is inserted –

"Drury Lane

East side (between its junction with Dongola Road and its junction with Rouge Bouillon)

West side (between its junction with Dongola Road and the northern boundary of "Inglis House")

West side (between a point 22 yards south of the northern boundary of "Inglis House" and its junction with Rouge Bouillon";

- (e) in the item "Halkett Place", in the entry beginning "East side (between Hilgrove Street and" there is inserted after those words "a point 6 yards north of";
- (f) in the item "Hastings Road", for the entry beginning "North side (between Roseville Street" there is substituted –

"North side (between its junction with Roseville Street and a point 13 yards east)";

- (g) in the item "Richmond Road", in the entry that begins "South and east sides", for "22 yards west and south" there is substituted "99 yards west and then south";
- (h) in the item "Roseville Street", the first entry beginning "East side (between Colomberie" is deleted and before the remaining entries there is inserted –

"East side (between its junction with Colomberie and a point 16.5 yards further south)

East side (between a point 32 yards from its junction with Colomberie and a point 14 yards further south)

East side (between a point 65 yards from its junction with Colomberie and a point 27 yards further south)";

(i) in the item "St. Aubin's Road", the last 3 entries after the entry beginning "South side (between Esplanade" are deleted and there is inserted –

"South side (between the eastern boundary of "Watkins Villas" and a point 39 yards west of its junction with the spur road at First Tower)

South side (between a point 14 yards east of the western boundary of First Tower Methodist Church and a point 76 yards east of its junction with the eastern arm of Seafield Avenue)

South side between a point 22 yards east of its junction with the eastern arm of Seafield Avenue to a point 9 yards west)

South side (between its junction with the eastern arm of Seafield Avenue to a point 8 yards east)

South side (between its junction with the eastern arm of Seafield Avenue to a point 9 yards west)

South side (between a point 29 yards east of its junction with the western arm of Seafield Avenue and the parish boundary)".

5 Schedule 8 (parking places on roads) amended

In Schedule 8 –

- (a) in Part 1, in the item "Colomberie", for "24" in its entry there is substituted "28";
- (b) in Part 1, in the item "Minden Place" for its entry there is substituted –

"South side (between a point 80 yards west of Bath Street and a point 16 yards further west)";

(c) in Part 1, after the item "Pier Road" and its entry there is inserted –

"Roseville Street

East side (between a point 16.5 yards from its junction with Colomberie and a point 15.5 yards further south)

East side (between a point 46 yards from its junction with Colomberie and a point 19 yards further south)";

- (d) in part 1C in the item "Beresford Street"
 - (i) the first entry is deleted,
 - (ii) in the second entry for "22" there is substituted "47";
- (e) in Part 2, in the item "Burrard Street" for its entry there is substituted –

"South side (between Don Street and a point 4 yards east of Burrard Place)";

- (f) in Part 2, in the item "Commercial Buildings", the last entry that begins "East side (between a point 272 yards" is deleted;
- (g) in Part 2, the item "Conway Street" and its entry are deleted;
- (h) in Part 2, the item "Esplanade" and its entries are deleted;
- (i) in Part 2, in the item "Gloucester Street", after "No. 15" in its first entry there is inserted "and a point 5 yards east";
- (j) in Part 2, in the item "Roseville Street", its entry is deleted and there is inserted –

"East side (between a point 92 yards from its junction with Colomberie and a point 18.5 yards further south)

East side (between a point 115 yards from its junction with Colomberie and a point 22 yards further south)

East side (between a point 169 yards from its junction with Colomberie and a point 7.5 yards further south)";

(k) in Part 2, in the item "St. Aubin's Road", the last 2 entries after the entry starting "South side (between the eastern boundary of "Watkins Villa" are deleted and there is inserted –

"South side (between a point 39 yards west of its junction with the spur road at First Tower and a point 15 yards further west)

South side (between a point 77 yards west of its junction with the spur road at First Tower to a point 55 yards further west)

South side (between a point 29 yards east of its junction with the western arm of Seafield Avenue and a point 10 yards further east)

South side (from a point 8 yards east of its junction with the eastern arm of Seafield Avenue to a point 6 yards further east

South side (between a point 22 yards east of its junction with the eastern arm of Seafield Avenue to a point 56 yards further east)";

(o) in Part 6, in the item "Richmond Road", for its entry there is substituted –

"East side (between a point 1 yard north of the southern boundary of No. 55 La Grande Pouclee and a point 19 yards south of the southern boundary of the property "Rose Cottage")";

- (p) in Part 6, the item "Roussel Mews" and its entry are deleted;
- (q) in Part 13, the item "Mount Bingham (link road to the Territorial Army Centre (south western arm))" and its entry are deleted;
- (r) in Part 15 before the item "Halkett Place" and its entry there is inserted –

6 Schedule 9 (St. Helier residential and business parking zones) amended

In Part 2, in the item "Richmond Road" for its first entry there is substituted -

"West side (from its junction with the entrance to Le Close de Debonaire to a point 2 yards north of the southern boundary of the property "1 Richmond Villas")".

7 Schedule 10 (parking of vehicles on roads for loading and unloading) amended

In Part 1 –
