THE ENVIRONMENT AND PUBLIC SERVICES COMMITTEE, in pursuance of Articles 62, 63 and 84 of the Road Traffic (Jersey) Law 1956¹ and after consultation with the Connétable of St. Helier, orders as follows –

1 Interpretation

In this Order, “principal Order” means the Road Traffic (St. Helier) (Jersey) Order 1996.²

2 New Article 27A

After Article 27 of the principal Law there shall be inserted, in Part 3, the following Article –

“27A Special business parking permit

- (1) A vehicle shall not be parked at any time in the parking space specified in Part 14 of Schedule 8 except if –
 - (a) it is parked by an employee of the ‘Good Companions Club’;
 - (b) it is parked for business purposes associated with the ‘Good Companions Club’; and
 - (c) the permission in writing of the Connétable for the vehicle to be parked in that place is displayed in the front window of the vehicle.
- (2) The Connétable may issue to a person written permission to park a vehicle in the parking space specified in Part 14 of Schedule 8 if the Connétable is satisfied that the person is an employee of the ‘Good Companions Club’ and that the vehicle in relation to which

the permit is sought will only be left in that place for legitimate business purposes.”.

3 Article 32 amended

In Article 32 of the principal Order, for the words “£150 for a period of six months’ validity of the permit” there shall be substituted the words “£200 for a period of 12 months’ validity of the permit”.

4 Part 1 of Schedule 1 amended

In Schedule 1 to the principal Order, in Part 1 –

- (d) after the item “Gloucester Street (between the Parade (west side) and the Parade (east side))” in the first column and the entry opposite in the second column there shall be inserted the following item and entry –

“Great Union Road (between Devonshire Place to Great Union
Devonshire Place and Great Street”;
Union Street)

- (e) for the item “Hue Street (between Lemprière Street and Union Street)” in the first column and the entry opposite in the second column there shall be substituted the following item and entry –

“Hue Street (between Lemprière Lemprière Street to Union Street”;
Street and Union Street)

- (f) for the item “Le Geyt Street (between Devonshire Place and Union Street)” in the first column and the entry opposite in the second column there shall be substituted the following item and entry –

“Le Geyt Street (between Union Union Street to Devonshire Place”;
Street and Devonshire Place)

- (g) after the item “Parade, The (eastern arm)” in the first column and the entry opposite in the second column there shall be inserted the following item and entry –

- “Parade, The (western arm) York Street to Union Street”;
- (h) for the item “Union Street” in the first column and the entry opposite in the second column there shall be substituted the following item and entry –
- “Union Street Le Geyt Street to New Street”;
- (i) after the item “Windsor Road (between Great Union Road and Garden Lane)” in the first column and the entry opposite in the second column there shall be inserted the following item and entry –
- “York Street Charing Cross to the Parade”.

5 Part 3 of Schedule 1 amended

In Schedule 1 to the principal Order, in Part 3, the item “Nelson Street (between the entrance to Nelson Street Car Park and Bath Street)” in the first column and the entry opposite in the second column, and the item “Vauxhall Street” in the first column and the entry opposite in the second column, shall be deleted.

6 Schedule 2 amended

In Schedule 2 to the principal Order –

- (a) in Part 1 after the item “Queen’s Road” in the first column and the entry opposite in the second column there shall be inserted the following item and entry –
