## LONG-TERM CARE (BENEFITS) (AMENDMENT No. 8) (JERSEY) ORDER 2019

*Made*

*6th December 2019*

*Coming into force*

*1st January 2020*

**THE MINISTER FOR SOCIAL SECURITY** makes this Order under Articles 3, 4 and 16 of the Long-Term Care (Jersey) Law 2012<sup>1</sup> –

### **1 Long-Term Care (Benefits) (Jersey) Order 2014 amended**

This Order amends the Long-Term Care (Benefits) (Jersey) Order 2014<sup>2</sup> and a reference to an Article by number without more is to the Article of the same number in that Order.

### **2 Article 8 (rates for long-term care benefit comprising standard care costs) amended**

For the table in Article 8 there is substituted –

“1	2	3	4
level of standard care	description of level of standard care	weekly cost for standard care in a care home or in a group home	weekly cost for standard care in a principal residence
1	Person requires long-term care on a daily basis but can be left alone for periods of at least 3 hours a day.	£390.39	actual costs of care, not exceeding the amount shown opposite in column 3
2	Person requires long-term care on a daily basis but cannot be left alone for periods exceeding 3 hours a day and the description for	£595.70	as above

	level 3 or 4 does not apply.		
3	Person requires long-term care throughout the day or night but care is not required 24 hours a day.	£861.07	as above
4	Person requires long-term care 24 hours a day, or if not 24 hours a day, with a greater degree of specialist care required than that required for level 3.	£1,082.55	as above”.

### **3 Article 9 (conditions for receiving a long-term care benefit comprising standard care costs) amended**

In Article 9(c) –

- (a) for “£336.98” there is substituted “£345.80”;
- (b) for “£36.82” there is substituted “£37.80”.

### **4 Article 10 (amount required to be paid towards standard care costs) amended**

In Article 10 –

- (a) in paragraphs (1) and (2)(a) for “£56,130” in each place there is substituted “£57,590”;
- (b) in paragraph (2)(b) for “£84,195” there is substituted “£86,390”.

### **5 Article 12 (co-payment benefits - loans to meet the costs referred to in Article 9(b), (c) and (d)) amended**

In Article 12(2)(b) and Article 12(5)(c) for “£336.98” in each place there is substituted “£345.80”.

### **6 Citation and commencement**

This Order may be cited as the Long-Term Care (Benefits) (Amendment No. 8) (Jersey) Order 2019 and comes into force on 1st January 2020.
