INCOME SUPPORT (GENERAL PROVISIONS) (AMENDMENT No. 19) (JERSEY) ORDER 2015

Made
Coming into force

18th December 2015 in accordance with Article 3

THE MINISTER FOR SOCIAL SECURITY, in pursuance of Articles 7 and 18 of the Income Support (Jersey) Law 2007¹, orders as follows –

1 Schedule 2 to the Income Support (General Provisions) (Jersey) Order 2008 amended

In Schedule 2 to the Income Support (General Provisions) (Jersey) Order 2008² –

- (a) for paragraph 5(f) to (ga) there shall be substituted the following subparagraph –
 - "(f) the following pension income
 - (i) in the case of one existing pensioner in the household, whichever is the greater of
 - (A) 100% of the first £55.23 of his or her pension income, or
 - (B) 23% of his or her pension income,
 - (ii) in the case of any other existing pensioner in the household, whichever is the greater of
 - (A) 100% of the first £35.77 of his or her pension income, or
 - (B) 23% of his or her pension income,
 - (iii) in the case of any new pensioner in the household, 23% of his or her pension income;";
- (b) in paragraph 6
 - (i) after the definition "earnings" there shall be inserted the following definition
 - " 'existing pensioner' means a person who has attained pensionable age before 1st January 2016 and who –
 - (a) was in receipt of income support before that date; or
 - (b) was the subject of an application for income support made before that date and approved on or after that date;",

(ii) after the definition "income" there shall be inserted the following definitions –

" 'new pensioner' means a person who has attained pensionable age and is not an existing pensioner;

'pension income' means income derived from a pension or annuity;".

2 Income Support (General Provisions) (Amendment No. 18) (Jersey) Order 2015 amended

Article 1(d) and (e) of the Income Support (General Provisions) (Amendment No. 18) (Jersey) Order 2015³ shall be revoked.

3 Citation and commencement

- (1) This Order may be cited as the Income Support (General Provisions) (Amendment No. 19) (Jersey) Order 2015.
- (2) Article 1 shall come into force on 1st January 2016.
- (3) The remainder of this Order shall come into force on the day after the day it is made.
