ROAD TRAFFIC (SPEED LIMITS) (AMENDMENT No. 12) (JERSEY) ORDER 2020

*Made**9th December 2020**Coming into force**14th December 2020*

THE MINISTER FOR INFRASTRUCTURE, after consultation with the Connétables of St. Brelade, St. Lawrence, St. Mary and St. Peter, makes this Order under Articles 21 and 84 of the Road Traffic (Jersey) Law 1956¹ –

1 Interpretation

In this Order “principal Order” means the Road Traffic (Speed Limits) (Jersey) Order 2003².

2 Schedule 1 (30 mph speed limit) amended

In Schedule 1 to the principal Order –

- (a) under the heading “St. Brelade” for the entry “La Route Orange” there is substituted –

“La Route Orange (from La Route du Petite Port to a point 95 yards north of La Rue de Sergenté)

La Route Orange (from a point 35 yards east of Le Chemin Particulier de L’Ecole to La Rue Don)”;

- (b) under the heading “St. Lawrence” for the existing entries there is substituted –

“Les Charrières Malorey (from the private road leading to the German Underground Hospital southwards to La Rue des Prés Sorsoleil)

Le Chemin des Moulins (from Ruelle de St. Clair to La Route de St. Aubin)

La Chenolles de Six Rues for a distance of 164 yards from Le Passage

La Grande Route de St. Laurent (from Le Mont Felard to Rue de Bas)

La Grande Route de St. Laurent (from La Rue du Vard to a point 35 yards north of La Rue Millbraie)

La Grande Route de St. Laurent (from 22 yards south of La Rue to La Rue de la Golarde)

La Longue Rue

(c) under the heading "St. Peter" –

(i) for the entry beginning "La Grande Route de St. Pierre (from a point 87 yards north" there is substituted –

"La Grande Route de St. Pierre (from a point 87 yards north of La Verte Rue to a point 72 yards north of La Neuve Route)",

- (ii) after the entry “La Rue de la Pointe” there is inserted “La Rue de la Ville au Bas”.

3 Schedule 2 (20 mph speed limit) amended

In Schedule 2 to the principal Order –

- (a) under the heading “St. Brelade” after the entry “La Route de la Baie” there is inserted –
 - “La Route Orange (from a point 35 yards east of Le Chemin Particulier de l’Ecole to a point 95 yards north of La Rue de la Sergenté)”;
- (b) under the heading “St. Lawrence” before the entry “Sandybrook Lane” there is inserted “La Rue de Haut”;
- (c) under the heading “St. Mary” –
 - (i) after the entry relating to “La Rue du Rondin” there is inserted –
 - “La Rue du Rondin (from La Verte Rue to a point 44 yards north of La Rue Mahier)”;
 - (ii) in the entry relating to “La Verte Rue” for the words “between the property known as “Broughton Lodge”” there is substituted “from La Rue du Rondin”.

4 Schedule 3 (15 mph speed limit)

In Schedule 3 to the principal Order under the heading “St. Lawrence” for the existing entries there is substituted –

“Les Charrières Malorey (from the private road leading to the German Underground Hospital to its northern end)
Le Chemin des Montagnes
Le Feuguere
Les Gelettes
Le Mont du Bu de la Rue
Le Mont l’Evêque
Le Mont Isaac
Le Mont Misere
Le Mont Perrine
Le Mont du Rocher
La Route de l’Eglise
La Rue du Douet de Rue

The unnamed road abutting the southern boundaries of the property known as "La Maison du Gardien" and the Parish Hall, and lying between La Route de l'Eglise and La Grande Route de St. Laurent

The unnamed road forming a junction with Le Mont Sorsoleil and Le Mont Isaac at its southern end and forming a junction with la Ruelle d'Avranches at its northern end".

5 Citation and commencement

This Order may be cited as the Road Traffic (Speed Limits) (Amendment No. 12) (Jersey) Order 2020 and comes into force on 14th December 2020.
