MOTOR VEHICLES (DRIVING LICENCES) (AMENDMENT No. 8) (JERSEY) ORDER 2007

Made

23rd November 2007

Coming into force

1st January 2008

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, in pursuance of Articles 4, 8, 9, 11, 12 and 84 of the Road Traffic (Jersey) Law 1956¹, orders as follows –

1 Schedule 3 to the Motor Vehicles (Driving Licences) (Jersey) Order 2003 substituted

For Schedule 3 to the Motor Vehicles (Driving Licences) (Jersey) Order 2003² there shall be substituted the following Schedule –

On road practical test in respect of category A1, A or P category by an applicant required to produce a compulsory basic training certificate	£34.30
Duplicate copy of certificate or statement in respect of result of theory test or practical test	£10.”.
