ROAD TRAFFIC (ST. HELIER) (AMENDMENT No. 23) (JERSEY) ORDER 2011

Coming into force

16th December 2011 30th December 2011

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, in pursuance of Articles 62, 63, 64 and 84 of the Road Traffic (Jersey) Law 1956¹, and after consultation with the Connétable of St. Helier, orders as follows –

1 Road Traffic (St. Helier) (Jersey) Order 1996 amended

- (1) The Road Traffic (St. Helier) (Jersey) Order 1996² is amended as set out in this Order.
- (2) Accordingly, a reference in this Order to an Article or Schedule by number is a reference to the Article or Schedule of that number in the Road Traffic (St. Helier) (Jersey) Order 1996.

2 Article 4 amended

After Article 4(3) there is added the following paragraph –

"(4) A vehicle shall be driven so as to make a left-hand turn only from the exit of a car park specified in the first column of Part 4 of Schedule 2 into a road specified opposite that car park in the second column of that Part.".

3 Article 6 amended

In Article 6(5) for the words "Part 1, 2, 3A" there are substituted the words "Parts 1, 2, 3, 3A, 3B".

4 Article 10 amended

In Article 10(1), after sub-paragraph (b) of the definition of "parking" there are inserted the following sub-paragraphs –

- "(ba) between the hours of 9 a.m. and 10 p.m. on any day, on any road specified in Part 1A of Schedule 8;
- (bb) between the hours of 9 a.m. and 10 p.m. on any day, other than a Sunday, on any road specified in Part 1B of Schedule 8;".

5 Article 20 amended

- (1) In Article 20(1) after the words "Part 3A," there is inserted the word "3B,".
- (2) In Article 20(2)
 - (a) after the words "Part 3A" where they first appear there is inserted the word "3B,";
 - (b) after sub-paragraph (a) there is inserted the following sub-paragraph
 - "(ab) in respect of a road specified in Part 3B, at any time between the hours of 8 a.m. and midnight on any day -10 minutes;".
- (3) In Article 20(4) after the words "Part 3A" there is inserted the word "3B,".

6 Article 21 amended

In Article 21(1) and (2) after the words "Part 3A," in both places where they appear there is inserted the word "3B,".

7 Article 21A amended

In Article 21A(1) for the words "3, 3A, 4, 5, 6," there are substituted the words "3, 3A, 3B, 4, 5, 6,".

8 Article 22 revoked

Article 22 is revoked.

9 Article 28 amended

In Article 28 -

- (a) for the definition "Cheapside Zone" there is substituted the following definition
 - "'Cheapside Zone' means the roads and parts of roads described in Part 1 of Schedule 9 under the heading 'ROADS AND PARTS OF ROADS WITHIN CHEAPSIDE ZONE';";
- (b) for the definition "Richmond Road Zone" there is substituted the following definition –

- "'Richmond Road Zone' means the roads and parts of roads described in Part 1 of Schedule 9 under the heading 'ROADS AND PARTS OF ROADS WITHIN RICHMOND ROAD ZONE'; ";
- (c) for the definition "St. Mark's Zone" there is substituted the following definition
 - "'St. Mark's Zone' means the roads and parts of roads described in Part 1 of Schedule 9 under the heading 'ROADS AND PARTS OF ROADS WITHIN ST. MARK'S ZONE';";
- (d) for the definition "St. Thomas' Zone" there is substituted the following definition
 - "'St. Thomas' Zone' means the roads and parts of roads described in Part 1 of Schedule 9 under the heading 'ROADS AND PARTS OF ROADS WITHIN ST. THOMAS' ZONE'."

10 Article 29A amended

In Article 29A -

- (a) in paragraph (d) the word "or" where it last appears is deleted;
- (b) in paragraph (e) for the words "Schedule 9," there are substituted the words "Schedule 9; or";
- (c) after paragraph (e) there is added the following paragraph
 - "(f) between 10 p.m. on one day and 8 a.m. on the following day in a parking place specified in Part 7 of Schedule 9,".

11 Article 30 amended

In Article 30 -

- (a) in paragraph (1), after the words "that vehicle" there are added the words "for the zone in which that person resides";
- (b) in paragraph (2), after the words "the business" there are added the words "for the zone in which that business operates".

12 Article 39 amended

For Article 39(1) there is substituted the following paragraph –

- "(1) Subject to Article 29D and the conditions prescribed in paragraph (2), a vehicle may be parked
 - (a) on a road specified in the first and second columns of the table in Part 1 of Schedule 10; or
 - (b) on the area marked on the surface of a footway or cycle track specified in the first and second columns of the table in Part 2 of Schedule 10,

during the time specified in the fourth column of that table only for the purpose of being loaded or unloaded in connection with a trade or business carried on in the vicinity.".

13 Article 40 amended

In Article 40(2) for the words "Part 2 or Part 3" there are substituted the words "Part 2, 3, 4, 5, 6 or 7".

14 Schedule 1 amended

In Part 1 of Schedule 1 –

- (a) the entry relating to Dummy Lane is deleted;

(d) after the entry relating to Roseville Street (between La Route du Fort and Havre-des-Pas there is inserted the following item –

"Roussel Mews (between the road leading to Le Clos de Balmain and Undercliffe Road) Northwards towards Undercliffe Road".

15 Schedule 2 amended

In Schedule 2, after Part 3 there is added the following Part –

COMPULSORY LEFT-HAND TURNS FROM CAR PARKS

Esplanade car park (exit leading to Castle Street)

Snow Hill car park (exit leading to the roundabout at the junction of Green Street with La Route du Fort)

Green Street".
