## **ECONOMIC DEVELOPMENT (2016 FEES) (JERSEY) ORDER 2015**

*Made**23rd December 2015**Coming into force**in accordance with Article 6*

**THE MINISTER FOR ECONOMIC DEVELOPMENT**, in pursuance of Regulation 7 of the Sea Fisheries (Licensing of Fishing Boats) (Jersey) Regulations 2003<sup>1</sup>, Regulation 3 of the Sea Fisheries (Underwater Fishing) (Jersey) Regulations 2003<sup>2</sup>, Regulations 2 and 5 of the Sea Fisheries (Fisheries) (Jersey) Regulations 2010<sup>3</sup>, Articles 193 and 196 of the Shipping (Jersey) Law 2002<sup>4</sup>, Articles 12 and 38 of the Weights and Measures (Jersey) Law 1967<sup>5</sup>, Articles 9 and 32 of the Tourism (Jersey) Law 1948<sup>6</sup>, and Articles 4 and 14 of the Places of Refreshment (Jersey) Law 1967<sup>7</sup>, orders as follows –

### **1 Sea Fisheries (General Fees) (Jersey) Order 2010 amended**

In the Sea Fisheries (General Fees) (Jersey) Order 2010<sup>8</sup> –

- (a) in Article 1 for the amount “£96.65” there is substituted the amount “£99.06”;
- (b) in Article 2(a) for the amount “£85.00” there is substituted the amount “£87.12”;

**FEES FOR REGISTRATION OR RENEWAL OF REGISTRATION**

<b>Class of registration</b>	<b>Amount of fee</b>
1. Hotel Register	£7.12 multiplied by the number of persons who can be lodged on the premises
2. Guest House Register	£4.74 multiplied by the number of persons who can be lodged on the premises
3. Self-Catering Accommodation Register	£6.61 multiplied by the number of persons who can be lodged on the premises
4. Youth Hostel Register	£3.98 multiplied by the number of persons who can be lodged on the premises
5. Holiday Camp Register	£4.99 multiplied by the number of persons who can be lodged on the premises
6. Camp Site Register	£3.98 multiplied by the number of persons who can be lodged on the premises.”.

**5 Places of Refreshment (Registration) (Fees) (Jersey) Order 2008 amended**

In Article 1 of the Places of Refreshment (Registration) (Fees) (Jersey) Order 2008<sup>21</sup>, for the figure “£88.00” there is substituted the figure “£88.88”.

**6 Citation and commencement**

- (1) This Order may be cited as the Economic Development (2016 Fees) (Jersey) Order 2015.
- (2) Article 4 of this Order shall come into force 7 days after the day this Order is made.
- (3) The remainder of this Order shall come into force on 1st January 2016.
