**HEALTH INSURANCE (PHARMACEUTICAL BENEFIT) (GENERAL PROVISIONS) (No. 2) (AMENDMENT No. 4) (JERSEY) ORDER 2007**

**THE MINISTER FOR SOCIAL SECURITY**, in pursuance of Articles 15(9) and 36 of the Health Insurance (Jersey) Law 1967<sup>1</sup>, orders as follows –

**1 Interpretation**

In this Order, “principal Order” means the Health Insurance (Pharmaceutical Benefit) (General Provisions) (No. 2) (Jersey) Order 2002<sup>2</sup>.

**2 Schedule 5 amended**

In Schedule 5 to the principal Order, for the fee “273” in respect of the item “1. Basic Dispensing fee” there shall be substituted the fee “285”.

**3 Schedule 6 substituted**

For Schedule 6 to the principal Order there shall be substituted the Schedule set out in the Schedule to this Order.

**4 Citation, commencement and application**

- (1) This Order may be cited as the Health Insurance (Pharmaceutical Benefit) (General Provisions) (No. 2) (Amendment No. 4) (Jersey) Order 2007.
- (2) This Order shall come into force one month after the date on which it is made.
- (3) This Order shall apply to pharmaceutical benefit supplied on or after 1st October 2007.
