EXTRADITION (TIME LIMITS) (JERSEY) ORDER 2004

THE HOME AFFAIRS COMMITTEE, in pursuance of Articles 11 and 120 of the [Extradition \(Jersey\) Law 2004](#), orders as follows –

Commencement [[see endnotes](#)]

1 Time limits for receipt of documents by Magistrate after arrest on provisional warrant

- (1) In respect of a request for the extradition of a person to a designated territory specified in column 1 of the Schedule to this Order, the period in Article 11(10) of the [Extradition \(Jersey\) Law 2004](#) for the receipt by the Magistrate of the documents to which Article 7(8) of the Law refers shall be the period shown in column 2 of that Schedule in respect of that designated territory.
- (2) A period shown in column 2 of the Schedule to this Order shall commence on the day on which the person was arrested.

This Order may be cited as the Extradition (Time Limits) (Jersey) Order 2004.
