1 Registration fee¹

The fee payable under Article 4(1) of the <u>Places of Refreshment (Jersey) Law 1967</u> in respect of an application for the registration, or the renewal of the registration, of premises as a place of refreshment is £101.

This Order may be cited as the Places of Refreshment (Registration) (Fees) (Jersey) Order 2008.
