## **CREMATION (FEES) (JERSEY) ORDER 2007**

**THE MINISTER FOR HEALTH AND SOCIAL SERVICES**, in pursuance of Article 4 of the <u>Cremation (Jersey) Law 1953</u>, orders as follows –

Commencement [see endnotes]

#### 1 Cremation fee<sup>1</sup>

The fee for cremating the remains of a person is -

- (a) nil if the person was under 18 years of age at death; or
- (b)  $\pounds 848.70$  in any other case.

#### 2 Medical certificate fee<sup>2</sup>

The maximum fee that a registered medical practitioner may charge for completing the medical certificate required by Regulation 6(a) of the <u>Cremation (Jersey)</u> Regulations 1961 and set out in Schedule 2 or 3 to the Regulations is £102.50.

#### 3 Citation

This Order may be cited as the Cremation (Fees) (Jersey) Order 2007.
