## CYCLE TRACKS (JERSEY) ORDER 2000

**THE ENVIRONMENT AND PUBLIC SERVICES COMMITTEE**, in pursuance of Articles 46 and 84 of the [Road Traffic \(Jersey\) Law 1956](#), orders as follows –

### 1

A way listed in column 1 of the table in the Schedule –

- (a) shall be a cycle track;
- (b) shall be used by pedal cycles only or, if described in column 3 of the table as “shared”, shall be used by pedal cycles and pedestrians; and
- (c) shall be used in the direction indicated in column 4 of the table.

### 2

This Order may be cited as the Cycle Tracks (Jersey) Order 2000.
