BANKRUPTCY (DÉSASTRE) (JERSEY) ORDER 2006

THE MINISTER FOR ECONOMIC DEVELOPMENT, in pursuance of Article 49A of the <u>Bankruptcy (Désastre) (Jersey) Law 1990</u>, orders as follows –

Commencement [see endnotes]

1 Interpretation

In this Order "the Law" means the Bankruptcy (Désastre) (Jersey) Law 1990.

2 Application for declaration

The prescribed liquidated sum for the purpose of Article 3(1)(a) of the Law is £3000.

3 Failure to keep proper accounts

The prescribed amount for the purpose of Article 19(2)(a) of the Law is £20,000.

4 Failure to disclose bankruptcy when obtaining credit

The prescribed sum for the purpose of Article 25(1) of the Law is £250.

5 Limit on wages, salary, holiday and bonuses given priority¹

The prescribed amounts for the purpose of Article 32(1)(b) of the Law are -

- (a) for clause (i), £6,300; and
- (b) for clause (ii), £1,800.

6 Courts of other jurisdiction to which assistance may be given by court²

For the purpose of Article 49(4) of the Law the prescribed countries and territories are -

- (a) Australia;
- (b) Finland;

- (c) Guernsey;
- (d) the Isle of Man;
- (e) the United Kingdom;
- (f) Republic of Ireland.

This Order may be cited as the Bankruptcy (Désastre) (Jersey) Order 2006.
